ITEM 1: Discuss Use of AHA to Help Develop Program Amendments

Discussion: The CBFWA Members approved funds for a contract with Mobrand-Jones

& Stokes (Mobrand) to facilitate the use of AHA to help the AFAC

develop Amendments to the Northwest Power and Conservation Council's

Fish and Wildlife Program. This will require a series of regional workshops to evaluate various "scenarios" of future actions (potential amendments). Dave Ward scheduled a teleconference with Mobrand for

October 5, 2007 to begin planning this exercise.

The AFAC had a number of questions regarding the work requirements and data needs for the AHA exercise. Larger agencies such as WDFW and ODFW requested a list of agency personnel involved with the HSRG, and

therefore familiar with AHA. Data needs (which partially dictate

personnel needs) were a foremost concern. The AFAC members requested

they be provided:

(1) A list of the current/known/proposed AHA inputs for each of the H's that will be used as the starting/review/template version for workshop sessions. For technical staff that are not familiar with how or why these data are organized or structured in AHA (and may not care), a listing of

> such parameters/metrics outside of the AHA context would actually be more effective (i.e., just a spreadsheet list of suggested parameter/metric values for the pertinent anadromous fish component).

2) A companion list of the documentations and assumptions associated with these "starter" input values.

This information then can be presented to knowledgeable staff that can either validate or offer alternative input values based on whatever documentation. The specific feedback/response from staff can then be compiled prior to the workshop and presented either by the contributing staff or another representative if the contributing staff cannot be present.

AFAC members discussed the need to ensure that the AHA exercise be consistent with other processes (remand, HSRG, etc.), and the need for appropriate long-term management of the data generated. The appropriate level of information (population, subbasin, etc.) was also discussed.

ACTION:

Dave Ward will talk with personnel from Mobrand on October 5, 2007 to discuss AFAC questions/concerns, and to develop a workshop schedule.

ITEM 1:

Discuss Use of AHA to Help Develop Program Amendments

Dave Ward provided the questions and concerns raised by the AFAC. Mobrand agreed to provide a list of the WDFW and ODFW personnel involved in the HSRG process. Mobrand also agreed to provide a "starter" list of AHA inputs needed for each population. Managers will need to provide values for the various scenarios to be run.

Discussion addressed the potential scenarios to be run. The draft list of scenarios (current plus four scenarios are possible) include:

- All scenarios can be run with hatcheries toggled both on and off
- The difference between scenarios (2) and (3) addresses FCRPS effects
- Scenario (4) is a placeholder for proposed changes in harvest
- Scenario (5) is undetermined climate change was discussed

A list of populations for each region needs to be developed. The list of starter inputs can then be distributed, and managers would then begin work to provide inputs for each scenario. All information for each population should be provided to Mobrand at least one week prior to the first workshop for that region.

Specific dates and locations need to be decided for each workshop. It would be helpful if a manager hosted each workshop so facility rental fees can be avoided.

Dave Ward will work with the managers to coordinate the effort needed prior to the first workshops.
