ITEM 1: Discuss the Draft Spreadsheet Summarizing Relationships Between Subbasin Objectives and Basin-Wide Goals and the Draft Briefing Paper for the Members.

During the July 23<sup>rd</sup> teleconference, the AFAC suggested a change that affects the results of the analysis slightly (reduction of pinniped-caused mortality to expected levels estimated by NOAA in the 2008 BiOp). In addition, some points were raised concerning consistency between CBFWA and the US v. OR TAC regarding how harvest and natural mortality are estimated, and about the implications of the results. The AFAC agreed to discuss these points prior to the draft briefing paper being sent to the Members. The Members will review the analysis and briefing paper on August 6.
