A final CBFWA-led review of the objectives should be completed by the end of November. The AFAC should discuss plans to complete this assignment.

ITEM 3: Update on Assignments to Lamprey Technical Workgroup

The AFAC should continue discussions on comments provided by the Lamprey Technical Workgroup (LTWG) regarding translocation.

In addition, the LTWG has been asked to provide technical comments on six proposals submitted through the U.S. Army Corps of Engineer's AFEP process (due November 14).

Finally, the AFAC should review questions on lamprey provided by the Fish Screening Oversight Committee, and consider asking the LTWG to prepare responses to the questions.

ITEM 4: AFAC Review of NOAA Fisheries' Data Dictionary and Monitoring Guidelines

On October 21, 2008 the MAG assigned the AFAC to work with non-AFAC members to review the draft data dictionary and monitoring guidance documents and report their findings back to the MAG on November 18, 2008. The AFAC
