ITEM 4: Anadromous Fish RM&E Framework

Ken MacDonald will provide an update on the status of the anadromous fish RM&E framework to be developed by the fish and wildlife managers. Ken will describe the near-term process, including potential time frame for a series of regional meetings. The AFAC members should discuss the potential role of the AFAC in this process.

ITEM 5: Review of the Status of the Resources Report

Dave Ward will provide a final update on the draft SOTR report and website, and solicit any final comments, revisions, or additions.

ITEM 6: Update on Lamprey Technical Work Group

The Columbia River Basin Lamprey Technical Workgroup (LTWG) has formed two subgroups to work on specific tasks:

(1) The Translocation Subgroup has started developing a review paper on lamprey translocation efforts. This is not a position paper, but rather a review of translocation, alternative management options, and a description of the problems resulting in the need for these management actions.

- (2) The Passage Standards Subgroup has re-formed to work on the assignment to "work with the Corps and other interested parties to develop lamprey passage objectives and related performance standards and measures." The subgroup is working on an initial product that will:
 - Define passage. Multiple definitions may be possible (e.g., percentage of fish entering fishways that successfully pass a dam vs percentage of all fish desiring to pass that successfully do so).
 - Catalogue potential metrics to be used.
 - Describe the data needed to assess the metrics and standards.
 - Describe the previous three items at multiple scales (e.g., basin-wide, project-specific, etc.).

The LTWG will hold its bi-annual symposium/workshop in October or November. The symposium/workshop will focus on translocation.
