ITEM 1: FY 02-04 Columbia Plateau Province Budget Balancing Process and

Schedule

Discussion: Tom Giese stated that there are two issues:

- 1. Allocation among the provinces that have yet to be reviewed.
- 2. Balance the budget for the Columbia Plateau Province.

The NWPPC indicated that the Columbia Plateau Province budget is in excess of available funds and they are also concerned about the funding availability for the provinces under current review. The NWPPC is drafting a letter requesting

CBFWA provide recommendations on the above two issues.

ACTION: The MMG took the following actions on allocation of the budget for all provinces:

- 1. An ad hoc committee will meet at CBFWA on Monday, September 10th from 10 a.m. to 4 p.m. to develop a budget allocation by province for FY 02. The committee includes Carl Scheeler, Bob Foster, Dave Statler, Susan Barnes, Pete Hassemer, Maureen Smith, John Palensky, BJ Kiefer and a representative from the Yakama Nation. Tom Giese will develop base budgets for FY 01 and out year budget material and send Friday, September 7th for the committee to review.
- 2. The MMG will meet at CBFWA Tuesday, September 11th from 9 a.m. to 12 p.m., to approve the recommendations of the ad hoc committee.

ITEM 2: **OSC Membership Issue and Survey Results**

Discussion: Brian updated the MMG with results to date, and encouraged the nine members

who have yet to respond to get their surveys back to Tana ASAP.

ITEM 5: CTUIR Emergency Funding

Carl Scheeler stated the CTUIR are requesting \$34,840.20 of emergency funding Discussion:

> in addition to the current fiscal year budget for the Wanaket Wildlife Area (Project #90-092-00). The funding is needed to address the effects of a July 28. 2001 wildfire in which over 1,700 acres of habitat were burned. The funding

would be used to purchase native grass seed and seeding equipment.

ACTION: This will be forwarded to the Quarterly Review meeting on September 7, a

placeholder will be identified, then the request will be sent to the CBFWA Members for Consent Mail approval. Upon CBFWA approval, the request will be included in the Council's meeting packet on September 14th for Council review on

September 26-27.
