ITEM 1: NPCC's Mainstem/Systemwide FY 2004-2006 Funding Decision to Reduce

the CBFWA Budget by 40 Percent – Rod Sando, CBFWA

Discussion: The NPCC approved a 1.2M recommendation for the CBFWA FY04-06 budget.

The budget can be restored to the 1.7M if CBFWA revises their task assignments in the proposal. Some specific task examples established by the MMG include integration of program implementation and assisting in subbasin planning meeting requirements for recovery plans and management plans. The revision will be presented to the MMG at the July 1 meeting for approval to meet the NPCC meeting packet dead line and presented at the July 15-16, 2003 NPCC

meeting in Warm Springs, Oregon.

ITEM 2: June 24, 2003 Senator Crapo Hearing to Examine NMFS's 2000

Implementation of the BiOp – Rod Sando, CBFWA

Discussion:

John Palensky will share the NMFS's testimony with CBFWA when he receives it from Bob Lohn who will be testifying in Washington D.C. at the hearing.
