#### Item 2: Strategic discussion on responding to the proposed Columbia River Data Management Center

At the 5/3/06 Members Meeting, Brian Lipscomb provided a brief overview of Chairman Karier's presentation and discussion. The MAG was directed to review the 4/27/06 Columbia Basin Data Center memo. On 5/16/06 the MAG held a lengthy discussion expressing various viewpoints and the group was consistent in the thought that CSMEP and StreamNet were developed to offer a similar product to what Chairman Karier is proposing. The MAG requested the MSRT to review and develop framework in which to formulate a response to Chairman Karier's memo in the form of project recommendations.

# MSRT Update: Tom Iverson

The MSRT met to discuss the data management proposals in the 07-09 suite of projects and discuss how the elements of each met part of the vision being contemplated by Chairman Karier. The outcome of this was to continue to meet with Tom to develop a first draft of how the projects could be recommended for funding in a manner to address some or all of the elements of the proposal.

#### **NPCC Request for Comments:**

On May 17, 2006 the NPCC issued a draft Columbia Basin Data Center Proposal – Council Document 2006-7 [http://www.nwcouncil.org/library/2006/2006-7.htm] for comments. The comments are due June 23, 2006.

#### **Discussion:**

Brian Lipscomb reiterated the reason for today's special meeting as explained in the description for Item 2. Tom Iverson updated the MAG on the MSRT process as it relates to formulating a response to the Columbia Basin Data Center proposal.

Tom directed the MAG to a memo he posted on the CBFWA site and sent out earlier today to the MAG summarizing results of the MSRT data management meeting held last week. He stated that there are several projects underway which address the inadequacies outlined in Chairman Karier's memo including PNAMP, NED, CSMEP, CBFWA and others.

Elements of the Columbia Basin Data Center Proposal currently exist within projects in the Fish and Wildlife Program.

The MSRT's 07-09 recommendations will demonstrate the connectivity between projects, and the CBFWA Status of the Resource addresses most of the Council's defined responsibilities, data gaps, oversight, etc. identified in the Data Center Proposal.

FY 07-09 project recommendations will provide opportunity to adapt proposals to fit within the regional information framework.

Consensus of the MAG was that the findings of the MSRT were valid but if forwarded on to the NPCC in the current format may result in rejection. It was suggested that a document be formulated addressing the points made by the MSRT but conveying the information in a way that it will be received openly. The revised response should concentrate on what the NPCC wants, what programs already exists and who provides them, articulate next steps, and modify the fish data in StreamNet, PNAMP, and CBFWA Status of the Resource projects. Take small steps. The FPC data issues will be addressed by the MSRT at a later date.

#### **Action:**

Dick Stone moved for a motion directing the staff to incorporate today's discussions and revise the draft response for review by the MAG to brainstorm via electronic conversations formulating a response to present to the Members' Meeting scheduled for June 7, 2006.

Phil Roger seconded motion. Motion passed, action approved.
