### ITEM 6: Innovative Project Proposals

On January 3, 2007, the Members approved for Chairman Trahan's signature and sent the CBFWA letter to Northwest Power & Conservation Council. The CBFWA letter recommends, "the Council utilize the current suite of unfunded 2007-09 proposals as the reservoir from which to select innovative projects. The Council should begin working with the fish and wildlife managers as soon as possible to (1) develop ranking criteria that address critical fish and wildlife protection, enhancement, and mitigation needs, and (2) determine which proposals meet these criteria."

This would save a year on process and speed up the funding for selected projects.

The message back from the NPCC is that the CBFWA F&W Managers should present a list of innovative project proposals to the F&W Committee and they might consider, however they will proceed with a solicitation.

# ITEM 8: Program Evaluation Process and Work Plan for CBFWA that will Result in Recommendations to Amend the Program

### ITEM 11: Wildlife O&M Issue Update on Presentation to NPCC

In the FY 07-09 recommendations to BPA the NPCC recommended that all wildlife O&M funding be considered interim. Asserting that neither the NPCC nor BPA had ever reviewed wildlife O&M costs, the NPCC advised that a final recommendation would be made subsequent to a review.

The NPCC held off on their IEAB assignment until CBFWA's input could be provided and they are also looking to include the Fish and Wildlife Managers in the overall evaluation of wildlife O&M. The NPCC would like a presentation from CBFWA at the January NPCC Meeting to inform this discussion and provide feedback to the IEAB.

CBFWA staff will provide an update on the presentation to the NPCC.

### ITEM 12: Status of the Resource Report Distribution

One hundred copies of the report have been printed and will be available for distribution to the region following the Members Meeting. ### ITEM 14: Celilo Falls Inundation 50<sup>th</sup> Anniversary Update

At the December 19, 2006 MAG meeting, John Platt reported that March 10, 2007 marks the 50<sup>th</sup> anniversary of the inundation of Celilo Falls. He stated that Celilo Falls was known as the "Wall Street of the West" because of the extensive trading of goods that took place there over time. The last Memorial was in 1982 at the time of the development of the Council program. John stated is an opportunity to focus public attention of hydro/fish and wildlife system.

The four tribes have events planned which include a feast at Celilo, and the Columbia River History Center will be host to a major conference addressing Celilo, and Roy Sampsel, Institute for Tribal Government, will provide education on hydro development as it applies to the Columbia.

Paul Koberstein of Cascadia Times (<a href="www.times.org">www.times.org</a>) wants to put together a whole issue on Celilo Falls.

CBFWA staff will provide information on the process and plan for the presentation to the Members at the February Members Meeting.
