

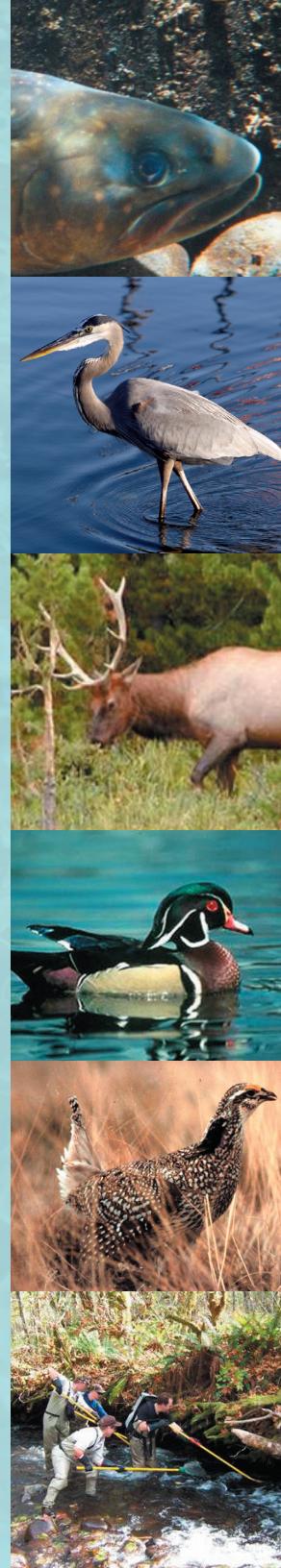
# CBFWA

The **Columbia Basin Fish and Wildlife Authority** (CBFWA) was chartered in 1987 by the region's fish and wildlife managers. The managers, including Tribes and state and federal agencies, established the Authority to coordinate the efforts of its Members to protect and enhance fish and wildlife resources of the Columbia River Basin through joint planning and action. The Authority provides a forum for the exchange of information among Members on matters affecting anadromous fish, resident fish, and wildlife resources and their habitat.

The activities of CBFWA create better informed, coordinated decisions and joint actions by the Members in relation to fish and wildlife. The Authority is a consensus-based organization, and the Members pledge to cooperate in good faith to participate in the consensus process.

Coordination of management activities is important because no single agency or tribe has authority over habitat necessary for all phases of the life history of a species or over all species within a particular ecosystem. The CBFWA Members are united in their desire to establish and maintain a mechanism to coordinate their management activities.

## Objectives of CBFWA

- Coordinate interagency activities among federal and state fish and wildlife management agencies and Indian tribes.
- Support development and implementation of cost-effective fish and wildlife programs.
- Prioritize fish and wildlife management needs while developing and coordinating mitigation activities associated with hydroelectric development and operations.
- Coordinate the development of cost-effective research, monitoring, and evaluation projects.
- Encourage effective communication and involvement with stakeholders, including the publication of the annual Status of the Resource report.
- Coordinate fish and wildlife managers' implementation of the Northwest Power and Conservation Council's Fish and Wildlife Program.
- Coordinate activities among Members and the land and water agencies.

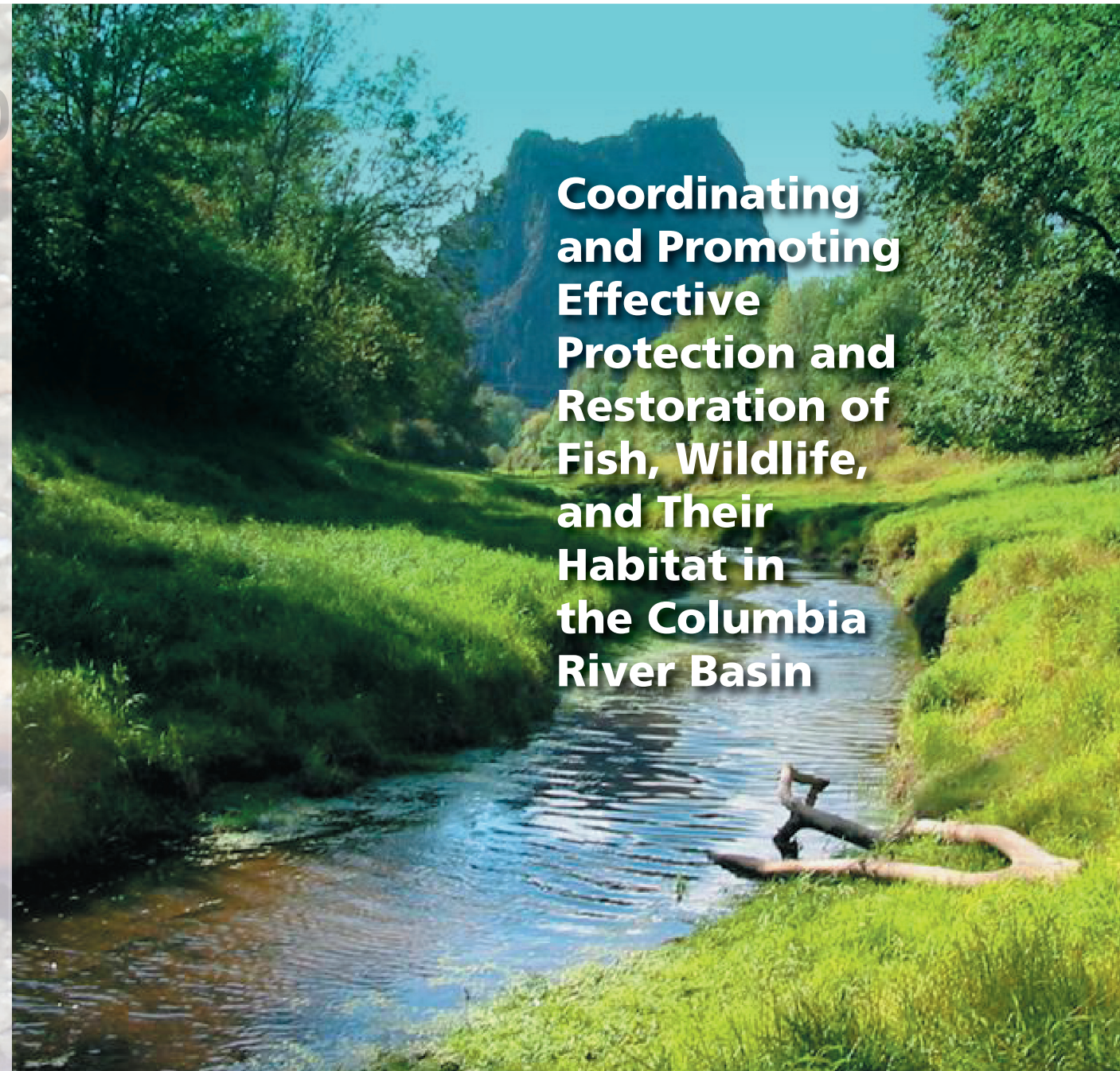
