JOB ANNOUNCEMENT

The Columbia Basin Fish and Wildlife Authority (CBFWA) is seeking a Regional Habitat Evaluation Procedures (HEP) Team Coordinator Assistant.

JOB TITLE: Regional HEP Team Coordinator Assistant

BACKGROUND

The CBFWA is a regional association serving the federal, state, and Tribal fish and wildlife managing entities of the Columbia River Basin. The CBFWA was established by charter to coordinate the efforts of its Members to protect, mitigate, and enhance the fish and wildlife resources of the Columbia River Basin. The CBFWA is a consensus organization and presents only consensus positions of its Members. The CBFWA Members established the Columbia Basin Fish and Wildlife Foundation (CBFWF), a non-profit corporation, to carry out the fiscal and staff managerial responsibilities of CBFWA.

NATURE AND SCOPE

This position reports to the Regional HEP Team Coordinator for CBFWA and will coordinate with other CBFWA staff as required. Under the direction of the Regional HEP Team Coordinator, the incumbent conducts HEP surveys, supervises temporary field staff, assists with coordinating HEP schedules and activities with CBFWA staff, CBFWA wildlife managers, and appropriate BPA Contracting Officer's Technical Representatives (COTR) as needed.

DUTIES

- Assists in planning and coordinating the HEP field activities;
- Train and supervise field staff;
- Assist field staff conduct HEP surveys;
- Manage field data and assigned budgets;
- Present HEP results to project sponsors as directed;
- Coordinate activities with CBFWA staff, wildlife managers, and BPA COTR's as needed;
- Assist in preparing reports and issue papers as needed;
- Perform other duties as assigned.

QUALIFICATIONS

Required

- Possess a Bachelors Degree with a minimum of 40 credit hours in wildlife, natural resources, biology, dendrology, or other sciences;
- Skilled in computer science and/or statistical analysis;
- Be familiar with probabilistic sampling;
- Have GIS skills (Arc-View, Maptech, Delorme software);
- Be skilled in plant identification;
- Three years supervisory experience;
- Be familiar with BPA wildlife mitigation crediting issues and loss assessment documents;
- Be willing to travel within the Columbia Basin as required and remain overnight at or near job sites;

- Possess good communication skills, both written and oral (interview will include a writing skills sample);
- Be able to perform the physical demands of working long hours in arduous field conditions and traveling across rough terrain.

Desirable

- Be familiar with regional natural resource issues;
- Be HEP certified or willing to complete training to become certified within 90 days of accepting the position;
- Ability to work well with a variety of people.

CONDITIONS OF EMPLOYMENT

The HEP Team Coordinator Assistant will be based out of Spokane, Washington. Residing in Spokane is not required; however, the HEP Team Coordinator Assistant is expected to commute to assigned office/work space. Field work sites are located in Washington, Idaho, and Oregon.

The Columbia Basin Fish and Wildlife Foundation (a nonprofit corporation under Oregon law) will handle all administrative functions of the position including salary, expenses, benefit package and administration of personnel rules.

The position is non-civil service. This position is classified as salaried/exempt. The salary level is a GS-11 \$56,411 - \$73,329 plus per diem and mileage allowance (government rates). *Filling this position is dependent on funding to be determined in July 2009*.

The trial service period is six months with a six month performance review. Annual performance reviews follow.
