CBFWA 2010 Policy Directives

- 1. ... participate in and support ongoing assessments of the status of the species and implementation of strategies and actions to help determine if protection, mitigation, and enhancement efforts are successful in the Columbia River Basin;
- 2. ... maintain a "Status of the Resources" (SOTR) website and annually prepare a written report summarizing the current information provided on the website;
- 3. ... monitor and report on activities of key regional forums where policies, programs, and actions that affect fish and wildlife are planned and implemented; and,
- 4. ... seek other funding sources other than BPA for other related activities.

Elements of Policy Directive #1

(Ongoing Basinwide Assessments)

- 1. High Level Indicators (Expected outcomes, report metrics, etc.)
- 2. Coordinated Monitoring Strategy (in context of MERR?)
- Coordinated Assessment (data provided in common format)
- 4. Data Management to support regional reporting
- 5. Reporting to help determine Program success

Anadromous Salmonid Monitoring Strategy (ASMS)

- 1. ASMS Submitted to ISRP on July 5
- 2. ISRP Report (and project reviews) due in January 2011
- ASMS will be incorporated into MERR following ISRP review
- 4. Work on coordinated assessment continues (next slide)
- 5. ASMS will be updated as appropriate

- A. Expand data sharing to complete VSP indicators, habitat effectiveness, and hatchery effectiveness
- B. Discuss regional assessments in context of BiOp check-ins and Fish and Wildlife Program success

Coordinated Assessments Work Plan

- 1. Constructing a draft Data Exchange Template (DET)
- 2. Host Fall workshop to approve template
- 3. Template applied to all relevant populations
- 4. Host Winter workshop to assess data management gaps including:
 - Partner Capacity
 - Shared Technical Infrastructure
 - Appropriateness of DET
 - Maintenance and Governance
- 5. Identify data management priorities to guide RME Categorical Review of data management projects
- 6. Expand DET beyond 3 VSP parameters in future



Lamprey Monitoring Strategy (LMS)

- 1. Monitoring Framework being developed by USFWS
- 2. LTWG will review and comment on document
 - LTWG meeting on October 19-20, 2010
 - It is anticipated that the USFWS Monitoring Framework will serve as the monitoring strategy (LMS) for the MERR
- 3. LMS will guide Geographic Reviews next Fall

- A. Develop coordinated assessment for lamprey data
- B. Incorporate into MERR following ISRP review during Geographic Reviews
- C. Data management and reporting to help determine Program success and support USFWS evaluations

White Sturgeon Monitoring Strategy (WSMS)

- Phase 1 sub-regional strategies developed while drafting proposals for RME Categorical Review
- 2. Submit collection of strategies to ISRP by August 18
- 3. Develop Phase 2 sub-regional strategies in Fall
- Develop common monitoring protocols guide for sturgeon projects in Fall
- 5. ISRP feedback on initial strategies by January 2011
- 6. Align sub-regional strategies with monitoring protocols guide for a basinwide WSMS in Feb-Mar 2011

White Sturgeon Monitoring Strategy (WSMS)

- A. WSMS will be incorporated into MERR after ISRP review
- B. Develop coordinated assessments for white sturgeon
- C. Data management and reporting to help determine Fish and Wildlife Program success

Bull Trout Monitoring Strategy

- 1. Meetings begin in September
- Describe existing monitoring strategies within each recovery unit
- 3. Align recovery unit strategies for basinwide approach
- 4. Complete first draft in time to guide Resident Fish Categorical Review next Spring

- A. ISRP will review and comment with project reviews
- B. Incorporate into MERR after ISRP review
- C. Develop coordinated assessments for bull trout
- D. Data management and reporting to help determine success of actions

Reservoir Fish Monitoring Strategy

- 1. Meetings begin in September
- 2. Develop sub-regional strategies
- 3. Align strategies for basinwide approach
- 4. Complete first draft in time to guide Resident Fish Categorical Review next Spring

- A. ISRP will review and comment with project reviews
- B. Incorporate into MERR after ISRP review
- C. Develop coordinated assessments for reservoir fish
- D. Data management and reporting to help determine Program success

Other Trout Monitoring Strategy

- Initiate following development of other monitoring strategies
- 2. Lack of interest due to extensive work on sturgeon, bull trout, and reservoir fish
- 3. Commitment to begin next Spring as those other efforts begin to wind down



Wildlife Monitoring Strategy

- 1. WAC has developed a basic framework for rolling up information currently collected by wildlife projects
- 2. WAC will explore HLIs that can be derived from existing monitoring strategies and data
- 3. Complete first draft of strategy in time to guide Geographic Review next Fall

- A. ISRP will review and comment with project reviews
- B. Incorporate into MERR after ISRP review
- C. Develop coordinated assessments for wildlife and their habitat
- D. Data management and reporting to help determine Program success
