RESOLUTION NO. 2012-<u>/5</u>

Approval of removing Burns Paiute Tribe from Columbia Basin Fish and Wildlife Authority (CBFWA)

WHEREAS, the Burns Paiute Tribe ("Tribe") is a federally recognized Indian Tribe and has adopted a Tribal Constitution ("Constitution") designating the Burns Paiute Tribal Council ("Council") as the elected governing body of the Burns Paiute Reservation; and

WHEREAS, the Council is authorized to act on behalf of the Tribe pursuant to Article VI of the Constitution, by Article VI(e) of the Constitution to manage all economic affairs and enterprises of the community and by Articles VI(s) to take any and all actions necessary and proper for exercise of powers and duties delegated to or vested in the Tribal Council; and

WHEREAS, the Tribe has a unique interest in the fish, wildlife and their habitat in the drainage basins of the Snake River and the Columbia River; and

WHEREAS, the Tribe has made repeated efforts to document and proclaim the negative impacts caused by manmade obstructions on the mainstern and tributaries of the Columbia and Snake Rivers; and

WHEREAS, the Burns Paiute has joined with other Tribes, state and federal agencies to mitigate the impacts caused by manmade obstructions, overuse and abuse of the mainstem and tributaries of the Columbia and Snake Rivers; and

WHEREAS, the Bonneville Power Administration provides regional coordination funding for the tribe to promote their sovereign interests in the Columbia River Basin Fish and Wildlife Program; and

WHEREAS, the Tribe has determined Columbia Basin Fish and Wildlife Authority (CBFWA) no longer meets the regional coordination needs of the Tribe; and

NOW THEREFORE BE IT RESOLVED, the Council hereby formally withdraws the Burns Paiute Tribe from membership in the Columbia Basin Fish and Wildlife Authority effective March 31, 2013; and

BE IT FURTHER RESOLVED, that the Burns Paiute Tribe will administer their regional coordination funds through the Upper Snake River Tribes Foundation.
