Release of the Draft Rolling Provincial Review Implementation: 2001-

2003 Report (Volume 1) and Presentation

**Discussion:** Neil Ward described the Draft Rolling Provincial Review Implementation: 2001-2003 Report which included an explanation of why the report was

created and how it addresses the objectives and tasks of the FY03 CBFWA proposal. The Rolling Provincial Review Implementation: 2001-2003 Report (Volume 1) represents a review of implementation efforts, results and budget tracking for fish and wildlife projects funded through the Rolling Provincial Review. The report is likely to serve as a tool for fish & wildlife managers, subbasin planners, federal regulators, and the power industry to track

implementation efforts and progress in each subbasin. Included in this comprehensive (i.e., includes wildlife, resident fish and anadromous fish projects) document are approximately 25% of the projects funded by the Bonneville Power Administration through the Columbia Basin Fish and Wildlife Program. The remaining projects will be reviewed by the CBFWA on September 21-24, 2004 and January 2005, with the resulting information being

incorporated into the Rolling Provincial Review Implementation: 2004-2005

Report (Volume 2).

the current Work Plan.

In the "Funding Diversity" area, the Members believe that CBFWA must move forward in developing additional sources of support. They requested more specific information on the process for applying for grants, worthy kinds of grants available, and the advantage of CBFWA accepting grants. The Members suggested that staff identify some specific grant opportunities, discuss them with the MMG and then develop proposals.

In the work plan area of "Public Relations," the Members discussed the value and benefits of CBFWA and staff, both to the individual Members' organizations and to the region. A key benefit of CBFWA in these times of regional change and turnover is to support stability and to provide leadership. The staff asked the Members to supply contacts and speak out about the contributions of the CBFWA organization and our accomplishments with Tribal council members, Congressional delegation, utilities, and the governors' office. The Members requested a power point presentation explaining CBFWA's organization and role in the region to share with the Tribal Councils. The Members requested that the history and evolution of CBFWA be resent and posted to the website.

In the third area of discussion, the Members supported using CBFWA as a forum to discuss the Members' policy differences, in order to clarify and define the differences in an attempt to resolve them.

The Members requested that the staff modify the form of communication in CBFWA by contacting the Tribal Policy Members by phone on important issues and writing a weekly status report of the issues in the regions which will be posted and easily accessible for review on the CBFWA website.

The CBFWA staff will incorporate points from today's discussions and Dick Stone's comments to prepare a revised draft of next years' work plan for review by the MMG. The Members will approve the final draft in the consent mail process.

# **Members Discussion and Direction on Regional Issues**

#### **Discussion:**

The Members decided more clarification is needed before a decision is made to consider another independent entity to replace BPA as the Fish & Wildlife funding administrator as a means to resolve its "conflict of mandate". Rod Sando reported that Greg Delwiche (BPA) is requesting a meeting with CBFWA to discuss the issues and would like to improve the working relationship between BPA and CBFWA. Most of the Members agreed to meet with Greg Delwiche and Bill Maslen of BPA.

#### **ACTION:**

The Members established a subcommittee to explore options, review the ATNI resolution, discuss ways to manage the funding program, listen to BPA's perspective and define future directions and strategies. Bill Hutchinson, IDFG; Claudeo Broncho, SBT; Mark Bagdovitz, USFWS; Dick Stone or Bill Tweit, WDFW and (tentatively) Rob Lothrop, CRITFC agreed to serve and Tom Giese, CBFWA will staff the effort. The subcommittee will meet to discuss problems with BPA's administration of the F&W Program funds, explore options for reform, and develop a proposal to reform the administration of the F&W funding. The subcommittee should use the GAO reports, Business Practices work group recommendations, and ATNI Resolutions as a starting point. The subcommittee should meet with Greg Delwiche and report to the September 2004 MMG and ATNI meetings. The Members will review the proposal at the January 2005 Members Meeting.
