Dear Messrs. Wolf and Fisher;

The Columbia Basin Fish and Wildlife Authority (CBFWA) received your letters dated April 5, and April 7, 2006, respectively, regarding the expectation of honorariums being provided to the independent scientific reviewers who worked through the Western Division of the American Fisheries Society (AFS) at the request of Affiliated Tribe of Northwest Indians (ATNI) to provide scientific analyses of the 2004 NOAA Fisheries Biological Opinion.

The CBFWA members would like to thank the Western Division of AFS for supporting the report and honor the scientists who volunteered their valuable time to develop it. Clearly, a report that presents independent science of this caliber provides the region with a meritorious perspective.

Your concerns were presented to the Members of CBFWA on May 3, 2006. Background correspondence was also provided, and the Members asked me to respond to your letters, which claim that honorariums were promised and have not been paid. Further, there seems to be a misunderstanding of the role of CBFWA staff as responsible for ensuring the timely payment of the honorariums. For the purpose of clarifying the record, CBFWA staff was authorized by the former Executive Director to assist the "Regional Strategy Group" only with coordination, facilitation, meeting room space, and administrative support on behalf of the request made by ATNI. The Members recognize that CBFWA staff played a role in coordinating the ATNI request for the scientific review, however, it was made clear all along to the strategy group, ATNI and AFS, that CBFWA was not responsible for the honorariums. CBFWA Members noted the request for honorariums was appropriately addressed in the February 24, 2005 letter from AFS to ATNI, and an invoice was sent by AFS to ATNI on September 28, 2005. The CBFWA does not have a contract or an obligation with AFS to provide the honorariums.
