- The MAG is recommending to Members that they instruct the Technical Committees to review both the subbasin team/province recommendations and the ISRP report and recommend whether or not CBFWA should provide comments.
- A MAG discussion ensued which prompted an amendment to motion to add instruction to the Technical Committees to 1) review BPA's classification of whether a project is capital or expense, and 2) has BPA applied the appropriate criteria and understood project?
- **Discussion:** In summary, this issue was redirected to the MAG from the 4/5/06 and 5/3/06 Members' Meetings for further discussion and clarification. In the 5/16/06 MAG meeting, the MAG finalized their discussion on this issue prompting the recommendation before the Members today. Brian Lipscomb reviewed the recommendation and Lynn Ducharme summarized the information and called for a motion.

RFAC: Neil Ward stated that the RFAC met last week to develop a process to review the projects. The goal is to have an overview of ISRP for committees review the first week of June.

- Discussion: Brian Lipscomb advised that CBFWA has not received a follow-up response.

- **Discussion:** Brian Lipscomb advised that contract amendment as previously directed by the Members was accepted by Sapphire Strategies and Gwen Lankford was here this week to formulate strategies with staff. She will present draft recommendations to the MAG at their 6/20/06 meeting and then to the Members at their July meeting in Spokane, WA.
