**Endorse PNAMP Steering Committee's Recommendation** 

Jennifer Bayer, PNAMP Coordinator is requesting that CBFWA consider endorsement, as a member of the PNAMP Steering Committee, the <u>Best Practices for Reporting</u>

	<u>Locational and Time Related Data</u> white paper. The paper was developed by the Northwest Environmental Data-Network (NED) and offers an opportunity to promote one important element for a strong and consistent data reporting foundation. The Steering Committee deliberations on this issue will be on 10/11/06.
	The Colville Confederated Tribes (CCT) supports the Summit Environment Consultants Ltd. request to change the date formatting in the NED white paper to the universal medium date DD-MMM-YYYY (e.g., 04-Oct-2006). This format is recognized internationally and eliminates confusion when interpreting and entering data.
	The MAG supports the CCT request to change the date format in the NED white paper and the PNAMP Steering Committee's recommendation.

Discussion:	Tom Iverson presented three draft documents that were recommended from the MAG for Members consideration regarding the CBFWA Response on the NPCC FY07-09 Project Selection Process and Funding Recommendations due 10/6/06:

	<ol> <li>Draft CBFWA Project Specific Response - (letter responding directly to the projects CBFWA has sponsored within the F&amp;W Program)</li> </ol>
Background:	The MAG provided comments to 12 bullets in the draft CBFWA Programmatic Response memo and discussed the subject and content of a letter commenting on the NPCC 07-09 Project Selection Process and their overall draft recommendations to BPA. The MAG requested that some bullets be combined, deleted, or broadened with specific examples and recommendations, including a request that the NPCC be consistent with their recommendations; if they choose to deviate from the process, they should provide an explanation of their deviations. The bullets were converted into a draft letter and an excel table with examples with specific projects effected by the process. Individual Members are providing comments to the NPCC FY07-09 project selection process and draft recommendations.
Discussion Letter 1:	Tom Iverson reviewed each paragraph and described the intent of the draft CBFWA Programmatic response regarding the 07-09 Project Selection Process. The Members provided comments on the draft response in paragraphs three, five, and seven. The excel table of the CBFWA essential projects at risk of being lost if not funded will be attached to the draft letter.
	If more time was available to comment we would could coordinate the staffs and draw language from each individual Members letters that would benefit everyone. Once the NPCC and BPA make their decisions there should be time to respond again by starting discussions on future strategies with NPCC. Collect specific evidence. CBFWA can

Included is our intent to describe how the NPCC's decision compares to the original proposed scope of work and budget and the NPCC draft scope of work and budget and to explain how the NPCC's recommendation affects the scope and budget and recommendation of what CBFWA believes the NPCC should do instead.
Discussion Letter 2:	Brian Lipscomb reads the revised draft CBFWA Project Specific Response to Council's Draft Recommendations for Fiscal Year (FY) 2007-2009 on the coordination projects CBFWA has sponsored within the F&W Program (i.e. #198906201, <i>Annual Work Plan CBFWA</i> ; #200303600, <i>CBFWA Collaborative Systemwide Monitoring and Evaluation Program</i> ; #200600600, <i>Habitat Evaluation Procedures (HEP)</i> ; and #200732100, <i>Data Management for System Operations</i> ). Attached to the draft letter is a list of past and future CBFWA coordination products, a proposal comparison identifying similar objectives in the Kalispel and Spokane Tribes proposal to the Grande Rhonde Model Watershed proposal, and the invitation letters to KT and ST welcoming there participation with CBFWA on regional issues.
