NPCC Meetings:	Rhonda stated that Brian Lipscomb attended the March NPCC F to provide the amendment strategy presentation and an update or process. The NPCC intends to have more meetings where project	n the coordination group

	located and it is hoped that CBFWA Members will attend those meetings. The next meeting is in Libby, MT on April 17-19 th .
Bonneville Power Administration (BPA) Actions:	Rhonda stated that the Council has not issued a formal response to BPA's decisions to date; however the issues have been identified and they have requested that BPA provide clarification and additional information.
Amendment Process:	Rhonda advised that the amendment process is being discussed at length at each meeting. Although a tentative schedule is in place, the NPCC has not yet called for amendments. Rhonda stated that she has not participated in an amendment process and would appreciate individual guidance on the process.
	Kathryn Brigham inquired about the NPCC plan for linking responsibilities. Brian Lipscomb responded that if the Umatilla tribe and other CBFWA Members feel that a strategy to offset BPA's obligations for the losses of the Federal Columbia River Power System (FCRPS) is an appropriate strategy, then it will be included as a recommendation to the NPCC.
Science Policy Conference:	Rhonda stated that the NPCC is planning a Science Policy Conference scheduled for September 12-13, 2007. A steering committee is being formulated to plan the conference and the NPCC has invited CBFWA staff to participate as steering committee members.
	Lynn Palensky, NPCC, provided additional information stating that the NPCC Chair initiated the Science Policy Conference with the intent to gather new information studied or researched over the last ten years. Lynn stated that this isn't a policy making forum but instead a pursuit for the best science to substantiate measures and possible recommendations for NPCC consideration.
	The steering committee's task is to assist in formulating conference objectives and provide recommendations on the conference structure.
	In response to Members' concerns about how the NPCC expects to deal with different perspectives and provide the F&W managers equal weight, Rhonda stated that they will use common sense and take into consideration the presenters' credibility and credentials in their perspective fields. The NPCC is hopeful that the steering committee will provide some sideboards on how to deal with this issue.
	An additional concern raised was that the name implies that science is making policy. Rhonda stated that the name could be changed so there's no implication in that regard.

	Bruce Measure, NPCC, was invited to provide NPCC perspective on the reinvigoration of the Fish Passage Center Oversight Board (FPCOB). Bruce stated that the FPCOB is a NPCC program; therefore, there must be oversight and accountability to understand their investment. Although the FPCOB previously created a platform for the Board, not much has been done. Bruce stated that he encouraged the revival of the Board to lend credibility and provide a common ground. He does not see the Board as a policy making body.
	Bruce stated that he is of the opinion that the Fish Passage Center (FPC) contract be transferred to CBFWA.
	The stated composition of the Board may be larger than necessary but should contain an uneven number in order to provide a tie breaker. The NPCC appointed Chair would serve as a tie breaker in favor of the NPCC's Fish and Wildlife Program.
	Policy considerations are premature; changes should be done in an amendment process.
	Bruce suggested that CBFWA request to meet with the NPCC formally to discuss this issue, or request additional time on the NPCC agenda.
Discussion:	Brian Lipscomb presented a letter that the MAG formulated in response to the NPCC's request for comment. The Members discussed the content of the letter and suggested edits to clarify the stance of the CBFWA Members.
Action:	Members moved to approve the letter with revisions emphasizing that 1) the FPC is meeting its obligations as established and contemplated in the Program; 2) the FPC is transparent and all data and analysis is posted in a timely manner on the public website; and 3) the lack of NPCC FPCOB meetings over the past year result in what appears to be a current attempt to fix what is not broken. Members requested the rewording of the 2 nd sentence/2 nd paragraph/2 nd page. Rob Walton abstained. No objections.
	Tom Iverson revised the letter as requested in the Members' action and presented the revised draft to the Members for their approval.

Discussion:	Brian Lipscomb advised that the press statement provided at the Celilo Falls Memorial on March 10, 2007, reportedly provided exposure to an estimated 1-1/2M people. Public relations accomplishments of the last year include the development of the press release process and a comprehensive press list and the redesign of the logo, stationary, website, and brochure.
	Public relations subcommittee member, John Platt, advised that the subcommittee met

	recently to review the past year's accomplishments and they agreed that the subcommittee's next steps include 1) development of community meetings to cultivate greater support and understanding; 2) define the message and the audience; and 3) conduct a written survey and site visits to gather anecdotal information (i.e., images, success stories, etc), formulate the information in a presentation, and through a workshop format synthesize a message that will best capture the public support for the protection, mitigation, and enhancement of fish and wildlife resources. John, Gwen Lankford, and Tana Klum all emphasized that the most important part of
	this process is the collaboration with the Members' communications staff.
