ITEM 1:	CBFWA Draft Letter to BPA and NPCC Regarding the Upcoming BPA WP-07 Rate Proceeding
Discussion:	Due to other meeting obligations, Dan Diggs, USFWS was unable to attend the teleconference and designated Mark Bagdovitz as acting chair.
	BPA is preparing to reopen the WP-07 Rate Proceedings, which provides opportunities for the fish and wildlife managers to influence funding by providing an order of magnitude estimate of fish and wildlife costs to BPA to ensure those costs are correctly identified and rates are sufficient to implement Program funding for projects that are approved through the various ongoing processes. BPA begins the formal process in early December 2007 and will make the final FY08 funding decisions in March 2008.
	On November 7, 2007, the Members directed the CBFWA staff to work with interested Members to draft a letter to the NPCC and BPA for Members endorsement identifying the list of project needs and associated costs for FY 08-09 and requesting that BPA and the NPCC work with us to identify an appropriate mechanism for providing the necessary funds for FY 08-09.
	On November 14, 2007, the Members met by teleconference to review and approve the draft letter and analysis. Brian Lipscomb stated that the Members he spoke with approve the draft letter as written, but if changes occurred today, he must bring the revised letter back for their approval.

The Members requested clarification in the third paragraph, second sentence of the draft letter. They agreed to add "by BPA" to clarify the sentence. The revision states, "Our analysis recognizes that the list of projects currently approved by BPA for funding under the Expense category of the Integrated Program budget is significantly less than the available funding." This sentence is in reference to BPA's posted July 2007 start of year budget. The funding identified in the CBFWA analysis is in addition to the posted budgets for each project.

Tom Iverson is confident that all the critical and essential needs identified by CBFWA members are listed in October 31, 2007 table. Tom reported that the ISRP recommended nine of the 107 projects as Do Not Fund (some with qualifications) and only seven projects were not reviewed by ISRP. Brian stated that the language in the draft is written to protect the Tribes who are involved in other rate processes.

The USFWS will abstain on this letter for reasons related to federal processes and the Remand. Mark Bagdovitz and Brian Lipscomb are contacting NOAA Fisheries for comments. The vice chair Montana Fish, Wildlife & Parks will sign the letter, if no Members object.

Action: The Members approved the draft letter as modified. No objections by the attending Members. The U.S. Fish and Wildlife Service abstain and Montana Fish, Wildlife & Parks will sign the letter. Brian Lipscomb will contact the absent Members for their decisions and notify the Members of the final action.
