**ITEM 1:** Introductions and Approval of Agenda

**ITEM 2:** Approve Draft Action Notes from the December 5, 2007 Members Meeting as

final.

Rob Walton, National Oceanic Atmospheric Administration (NOAA), requested an edit to two sentences under Item 6 Hatchery Scientific Review Group (HSRG):

1st edit in paragraph four, second sentence - Rob requested the following

change:

Rob, while on the conference call with the Members, was attempting to gather additional information to clarify the reason for the HSRG's additional funding request but was not able to provide emphatic specific answers in response to all

questions raised by CBFWA Members within the meeting.

 $2^{nd}$  edit in paragraph six, third sentence – Rob requested the following change:

**Detailed** information on the HSRG project is was not readily available; therefore, without the information, not all of the members didn't feel felt comfortable adding it

to the critical and essential list at this time.

**Action:** The Members approved the December 5, 2007 draft action notes as final with edits

as requested by Rob Walton. No objections.

# ITEM 3: Amendment Timeline Extension Request Letter to the Northwest Power and Conservation Council (NPCC)

The Members discussed a draft letter to Dr. Tom Karier, NPPC, requesting the NPCC keep the record for Fish and Wildlife Program amendment recommendations open until March 1, 2008. The letter stated that the additional thirty (30) days would allow the fish and wildlife managers' time to complete the internal policy review processes required by their respective directors and/or tribal councils.

#### **Members' comments:**

- Lynn DuCharme, Confederated Salish and Kootenai Tribes of the Flathead Reservation (CSKT), advised that CSKT is sending correspondence to the NPCC requesting an extension of sixty days.
- Rob Walton, NOAA, added that the Federal Columbia River Power System (FCRPS) and Upper Snake River basin Biological Opinions (BiOp) are due March 18, 2008, which would only give Members thirteen days for review (if granted a sixty day extension) and questioned if that was enough time. Rob suggested that one option would be to request an extension of "at least" sixty days to leave the door open for additional time, if needed, after reviewing the BiOp's.
- Larry Peterman, Montana Department of Fish, Wildlife and Parks (MDFWP), stated that MDFWP would prefer a sixty day extension request.
- Dan Diggs, USFWS, stated that USFWS would be comfortable with a sixty day extension request.

Brian Lipscomb advised that it is his understanding that the NPCC would have difficulty granting an extension beyond sixty days as they would not want to delay opening the NPCC Power Plan process.

Dan Diggs called for a motion to modify the letter requesting an extension of sixty days instead of thirty days.

#### **Members' comments:**

Gary James, Confederated Tribe of the Umatilla Indian Reservation (CTUIR), suggested that information be added regarding the BiOp reviews. Rob Walton, NOAA, suggested the following edits to the letter (note bold/italics) to be inserted in the last sentence in the first paragraph:

The additional thirty (30) sixty (60) days will allow the fish and wildlife managers time to review the Federal Columbia River Power System (FCRPS) and Upper Snake River basin Biological Opinions and to complete the internal policy review processes required by their respective directors and/or tribal councils.

Action:

The Members approved the timeline extension request letter with the modification to expand the extension request to sixty (60) days and add "to review the Federal Columbia River Power System (FCRPS) and Upper Snake River basin Biological Opinions and" to the last sentence in the first paragraph. No objections.

#### ITEM 4: Coordination Proposal Presentation to the NPCC

Brian Lipscomb, advised that CBFWA has an opportunity to make a coordination proposal presentation to the NPCC at their January 2008 meeting. This presentation would be in follow up to what has already been communicated in writing to the NPCC on December 10, 2007:

Tom Iverson provided a presentation for Members' review. Tom advised that the presentation will be updated to add CBFWA's response to the distributed services request and a final review will be done to make sure that the slides are consistent with the final CBFWA work plan.

CBFWA staff will update the presentation and add a slide to reflect the response to the distributive services request and will review the presentation to make sure slides are consistent with the final CBFWA work plan. **Abstention:** 

Sue Ireland, Kootenai Tribe of Idaho (KTI), advised that they are abstaining pending Tribal Council policy deliberation.

## ITEM 5: Status of the Resource (SOTR) and NPCC M&E Report

Brian Lipscomb stated that he wanted Members to be aware that the NPCC staff is planning to prepare an M&E report in coordination with the SOTR report. The focus is on pulling information from within the region from an environmental standpoint. Brian stated that there's been confusion about how the two reports will ultimately fit together. Brian advised that Tony Grover, NPCC, has been invited to discuss this with Members at the January 17-18, 2008 meeting in Vancouver WA.

The 2006 SOTR report will be presented to the Members at the January meeting in Vancouver WA, allowing for a thirty day review by the agencies and tribes before it is presented to the NPCC at their March 2008 meeting.

#### ITEM 6: Public Relations Contract Modification

Brian Lipscomb updated the Members on some necessary modifications to the public relations work plan. Brian advised that the current public relations statement of work (SOW) with Gwen Spencer, Sapphire Strategies, was based on the fact that Tana Klum was facilitating and coordinating the public relations process among the Members and the Members Advisory Group (MAG) public relations subcommittee. Given Tana's resignation from CBFWA and the subsequent decision to not fill the position, it is not feasible to continue with the original work plan. As a result of this change, Gwen Spencer's efforts are being refocused.

Gwen reviewed the modified SOW with the Members:

John Platt, CRITFC, praised Gwen's work but raised concerns regarding Gwen becoming the "face of CBFWA," given Rhonda Whiting's role with the NPCC (Rhonda is Gwen's mother). John was concerned that this situation may create a nepotistic situation and put Gwen and Rhonda in a compromising position.

Brian stated that there was never an intention to put Gwen Spencer or Rhonda Whiting in a compromising position, nor is it intended for Gwen to provide presentations to the NPCC or other parties. CBFWA is working with Gwen to create the talking points and the PowerPoint presentation utilizing Gwen's professional expertise with regard to working with external media.

Brian stated that he will follow up with John Platt directly to further address his concern.
