Dear Mr. Booth:

The Members of the Columbia Basin Fish and Wildlife Authority (CBFWA) recently adopted a charter to formally establish the Fish Screening Oversight Committee (FSOC). The FSOC has been facilitated by CBFWA for a number of years, but until now had not been operating as a chartered committee. The functions of the FSOC include, but are not limited to:

- (1) Providing CBFWA Members with technical information necessary to facilitate effective planning and implementation of fish screening projects in the Columbia River Basin;
- (2) Facilitating discussion among fish managers of the technical merits and implications of projects and issues to find consensus agreement;
- (3) Providing a forum for federal, state, Tribal, and private entities to exchange information on fish screening concerns in the Columbia River Basin; and,
- (4) Planning and implementing the Bi-annual Pacific Northwest Fish Screening and Passage Workshop.

As you are aware, Mitchell Act funding for fish screens is currently inadequate to fully cover necessary operation and maintenance costs, and further reductions in Mitchell Act funding for screens are possible. The CBFWA Members recently assigned the FSOC to work with the CBFWA Members Advisory Group (MAG) to identify annual funding needed to cover costs of screen replacement, operation and maintenance, and to develop strategies to maximize the likelihood of obtaining this funding.

We note in Tony Grover's January 21, 2009 letter to Bonneville Power Administration (BPA) regarding the Oregon Fish Screens Project that the Council is also interested in a comprehensive strategy for fish screening including the Mitchell Act Program. As FSOC completes its work, we would be glad to share it with the Council, BPA, and others, and collaboratively pursue any strategies.
