During your review, please realize that the CBFWA staff is still in the process of editing the documents for style, consistency, grammar, etc. The CBFWA staff is seeking your assistance in ensuring that the information presented in this report is the most current and accurate. In most cases, the most current population data that we were able to mine, through various sources, are from 2007; however, for some focal species, 2008 data were available. The following data needs remain and we hope that you will be able to assist us in filling-in the blanks:

- 1. Wild juvenile production for anadromous and resident fish (if you have any such data please contact Dave Ward for anadromous fish, or Neil Ward for resident fish).
- 2. 2007 hatchery release goals, releases, return goals, and returns to hatcheries/traps (please contact Neil Ward).

The CBFWA has committed to releasing this to the public in July 2009. To ensure that the document is available by mid-July, we ask that you provide your comments and information to Neil Ward at neil.ward@cbfwa.org no later than COB Wednesday, June 24.
