SUBJECT: FY2012 CBFWA *Transition* Work plan and Budget Information

The CBFWA FY2012 Work plan and Budget are due to BPA on December 31, 2011 for contract renewal preparation. The CBFWA contract runs from April 1 through March 31 each year and BPA requires 90 days to implement a contract renewal.

CBFWA staff has prepared a preliminary work plan and budget for FY2012 and will discuss this in detail with the Members Advisory Group (MAG) on December 6, 2011. However, we felt that we should discuss the concepts of the approach with the Members preceding the MAG meeting.

According to staff best estimates, it is anticipated that CBFWA will have a budget of \$842,292 (Appendix 1). By latest count, CBFWA will have ten Members starting April 1, 2012 including the Burns-Paiute Tribe, Shoshone-Bannock Tribe, Shoshone-Paiute Tribe, Fort McDermitt Tribe, Umatilla Tribe, Warm Springs Tribe, Yakima Nation, Kootenai Tribe, US Fish and Wildlife Service, and NOAA Fisheries.

The work scheduled for FY2012 will be limited due to significantly reduced funding for CBFWA. We have lost the anadromous fish coordinator and will not be able to refill that position. This will leave two coordinators to facilitate technical and policy meetings in the upcoming year. Also, with the reduced funding, CBFWA is moving to a new location – yet to be determined. Finally, a big impact on CBFWA staff time will be the need to rewrite the CBFWA Charter and Columbia Basin Fish and Wildlife Foundation (Foundation) By-laws.

FY2012 Preliminary Work Plan

Transition to Facilitation Services Model and Continuation of the 2010 Strategic Plan for Adaptive Management Implementation and Evaluation

Policy Directive #1

- Continue facilitation of CBFWA technical committees; however, we expect
 a reduction in the number of meetings (limit to quarterly?) and reduced
 staff support for development of products.
- Committees will address only urgent matters and will slow progress on implementation strategies.
- Solicit support for Foundation proposal for future funding of focus workgroups to replace CBFWA technical committees and continue to support coordinated assessments for fish and wildlife.

Policy Directive #2

- Maintain the Status of the Resources website; however, discontinue upgrades during this transition period.
- Solicit support for Foundation proposal for future funding of the SOTR project.
- Continue to work with Council to support their High Level Indicator (HLI) report.

Policy Directive #3

- Maintain "eyes and ears" function for CBFWA Members; begin transition to monthly updates and reports envisioned in Foundation proposal for FY13-15 funding.
- Conduct bi-monthly MAG meetings, except as necessary to update CBFWA Charter and secure future regional coordination funding.
- MAG will consider preparations and plan for upcoming Program amendment process.
- Conduct two Members meetings during FY2012, unless additional meetings are necessary to adopt revised CBFWA Charter.

Additional CBFWA staff efforts will largely focus on important transition related activities which include:

- 1) Move office location to obtain a reduction in rent of 50%.
- 2) Rewrite CBFWA Charter to align with current Membership and to deemphasize technical workgroups and focus on "eyes and ears" and policy forums.
- 3) Rewrite Foundation by-laws to support Facilitation Services model proposed for FY13-15 funding.
- 4) Support Members participation in regional coordination project review process. NPCC decision on regional coordination funding will not occur until June 2012.
