


CBFWA Today

- 2012 is transition to restructure CBFWA and CBFWF to provide Program facilitation services


FY2012 Budget

Status of the Resources Project

- Website updated monthly
- Working with the USFWS, develop the bull trout section
- Incorporate survey results
- Develop proposals in an attempt to secure grants for supplemental funding

Anadromous Fish Focus Workgroup

- Coordinated Assessments
 - Continue development of Data Exchange Template (DET)
 - Convene summer workshop to adopt DET
- Assist with habitat and hatchery effectiveness evaluations, if requested

Lamprey Technical Workgroup (LTWG)

- Continue development of a Pacific lamprey monitoring strategy

- Two technical workshops:
 - Ecosystem models to explore regulations and removal options
 - Managing non-native fish
- Work with MonitoringMethods.org to address resident fish
- Discuss fish screen/passage needs for resident fish in preparation for FSOC
