ITEM 4: Develop review groups to review the technical merits of resident fish proposals submitted for funding consideration in the Mainstem and Systemwide Province

During the August 7-8, 2001, RFC Meeting, the RFC agreed that a review group would be assigned, based on expertise and experience, to perform technical reviews of proposals submitted for funding through the Provincial Rolling Review. The review group will review and report their findings to the RFC for approval pending a management review by the full RFC. Table 1 is a compilation of resident-fish-oriented proposals (proposals are available on the CBFWA website) submitted for funding consideration in the Mainstem/Systemwide Province and RFC participants that either volunteered or were assigned to review the proposal. The ISRP comments and the project sponsor's responses to the ISRP comments will be available on the CBFWA website by the week of August 5, 2002. Comments will be due to Neil Ward no later than Thursday, September 5, 2002.

For purposes of consistency with past reviews, the project reviews will be performed by implementing the same criteria (Table 2) used by the subbasin review teams. Reviews will be provided, in an anonymous fashion, to the RFC on Friday, September 6, 2002.

ITEM 5: ODFW and BPA update on the status of Project 199405400

Dave Ward provided the RFC with an update regarding a meeting he had with Neil Ward, Ron Morinaka, and Al Hemmingsen to discuss Project 199405400's budget. Dave indicated that project funding was approximately \$295,000 in FY 2001 and that although ODFW received approximately \$351,000 in the Columbia Plateau for FY 2002, only \$86,400 should be counted as ongoing. The other \$264,500 was for E-Mapping and telemetry work moved from Project 25088 per the ISRP recommendation. Dave indicated that the \$264,500 will not be considered when comparing project costs between 2001 and subsequent years. In addition, meeting participants agreed that the costs for ongoing objectives in the Blue Mountain for FY 2002 will be either \$312,000 or \$233,000, depending on the final determination as to whether the Imnaha telemetry work is considered ongoing. It was decided during the meeting that all funding will be through a modification of the existing contract for the Columbia Plateau portion of the project thus each province will not have a separate contract.

ITEM 6: National Environmental Policy Act (NEPA) requirements

Colleen Spiering provided a review of the process that is required to ensure NEPA coverage. Project sponsors are reminded that it is their responsibility to contact their COTR to initiate the steps required to ensure NEPA coverage.

ITEM 7: Update on resident fish conditions in Montana

Brian Marotz provided the RFC with an update on the results of fish and gas saturation monitoring associated with the recent flood control spill emergency studies performed at Libby Dam during the spring of 2002.
