ITEM 1: CBFWA Review of Resident Fish Proposals in the FY 07-09 Project Selection Process –

Neil Ward and Lawrence Schwabe informed the RFAC that the Members Advisory Group (MAG) has directed the CBFWA committees to identify any issues resulting from the provincial and ISRP project proposal reviews that they believe should be addressed through the CBFWA. The RFAC discussed the potential review of proposals and decided that due to time limitations, they would not be able perform technical reviews; however, the RFAC directed Neil to review the Independent Scientific Review Panel's (ISRP) comments and the recommendations from the province workgroups and to identify issues that should be addressed by the RFAC. Neil will review the ISRP's comments during the week of June 5, 2006, and provide a list of issues that warrants an RFAC review no later than Thursday, June 8, 2006. The recommendations from the province workgroups are due to the Northwest Power and Conservation Council no later than June 16, 2006. Neil indicated that he will review the province recommendations during the week of June 19, 2006, and provide an overview to the RFAC by June 23, 2006. For those that will not be able to attend the RFAC retreat, Neil requested that they forward their comments, relative to the identified issues, to him no later than June 30, 2006.
