ITEM 5:	Independent Scientific Advisory Board's (ISAB) Non-native Species Impacts on N Salmonids and Guidelines for Use of Non-native Fishes in Resident Fish Substitut	

TTEM 5:

Projects Review

In June 2007, the Northwest Power and Conservation Council (NPCC) endorsed the ISAB's proposal to conduct a review with the following tasks and objectives:

Salmonids and Guidelines for Use of Non-native Fishes in Resident Fish Substitution

Review and describe biological impacts and risks to native salmonid populations from • non-intentionally and intentionally introduced species

• Review and describe the current status of management actions taken towards reducing or eliminating such impacts (e.g., brook trout and lake trout eradication efforts)

- Recommend strategies for protecting against or eliminating invasive species
- Recommend scientific guidelines for using resident fish substitutions

The ISAB intends to initiate this review as soon a possible in order to submit the report no later than Fall 2007, to inform the NPCC's program amendment process. Due to time limitations, this item could not be discussed in detail. Neil Ward has contacted Erik Merril (NPCC's ISAB liaison) to secure an opportunity to provide a coordinated presentation to the ISAB during their September 14, 2007 meeting in Portland. The focus of the presentation will be resident fish substitution program, the state of ecosystems to support native and non-native fish populations, the role of resident fish habitat work, and efforts to manage predation by non-natives and interbreeding with non-natives throughout the entire Columbia River Basin.

ACTION Neil Ward will be contacting RFAC participants to assemble a group of presenters for the meeting.

ITEM 6: Joint CBFWA Committee Amendment Strategy Workshop-Update

- **4:45-5:30** Jim Uehara and Neil Ward provided an update regarding the amendment workshop that was convened in Spokane from July 24-25, 2007. Jim and Neil informed the participants that the workshop participants advised the RFAC to develop a: 1.) process for assessing resident fish losses throughout the Columbia River Basin, 2.) formula to compute the annual number/harvest of resident fish required to equal the annual anadromous fish losses due to hydro-development and annual operations. The RFAC discussed the proposed strategy and measure exercise of the CBFWA amendment; however, concerns were expressed that the MAG did not direct the committee to develop strategies and measures.
- ACTION: Neil Ward will develop a draft memo, for the RFAC's review and eventual submittal to the MAG, which describes the RFAC's proposed process for addressing resident fish losses.
- ACTION: Neil Ward will develop a draft memo, for the RFAC's review and eventual submittal to the MAG, which describes the RFAC's conclusion that a formula to compute the annual number/harvest of resident fish required to equal the annual anadromous fish losses due to hydro-development and annual operations could not be developed.

ITEM 7: ISRP Lake Roosevelt Kokanee Program Review

- **5:30-5:50** On July, 18, 2007, the ISRP released the *Lake Roosevelt Kokanee Program* Review. The ISRP concluded that there is no scientific justification to continue artificial production of kokanee for stocking Lake Roosevelt or programs to develop and support naturally produced kokanee. However, the ISRP suggested that if it could be conclusively demonstrated that the entrainment problem was controlled or significantly reduced, if the walleye population was significantly reduced and managed, and if drawdown levels were reduced or managed, then artificial production and/or support of natural production of kokanee could be-reinitiated. The ISRP found that kokanee production for experimental stocking in Banks Lake is justified
- ACTION: The RFAC recommended that the STOI, WDFW, CCT should contact the RFAC if they would like the RFAC to comment on the ISRP report.

ITEM 8: Amendment Measure and Strategy Exercise

The RFAC did not initiate the exercise in which the meeting participants were scheduled complete the draft measure and strategy template for each focal species in the subbasins for which the mangers have management responsibilities due uncertainties associate with the assignment.

ACTION: Neil Ward will seek clarification from the MAG during the August 2007 meeting.

ITEM 9: StreamNet SOW – Resident Fish Needs

The RFAC discussed the types of resident fish data that should be available through StreamNet. The participants agreed that trend data (e.g., abundance, redd counts, density) and fish distribution data should be priorities for the StreamNet project. In addition, the RFAC suggested

that consideration should be given relative to creating a tribal resident fish data coordinator position at StreamNet in which the individual would be responsible for collecting data from the tribes throughout the Columbia River Basin.
