## ITEM 4: Resident Fish Losses: Development of Methodology to Assess Operational Losses

The NPCC's Program contains the following objective to address resident fish losses: "Complete the assessments of resident fish losses resulting from the development and operation of the hydrosystem, when and where there is agreement on the appropriate methodology and prioritization of an assessment. As these are available, the Council will consider adopting the loss assessments into the Program." Sheri Sears will lead the RFAC in a discussion regarding the development of an appropriate method to assess resident fish losses that are associated with the operation of the Federal Columbia River Power System.
