ITEM 1: Use of RVI Values Developed by NHI for Reservoir Open Water

The Northwest Habitat Institute has developed RVI values for various habitats. The WC will discuss the merits of adopting the NHI values for open water.

ITEM 2: Crediting for Wildlife Values in Anadromous Fish Projects

There are both current and planned acquisitions intended to primarily benefit anadromous fish. BPA has indicated that they intend to take credit for wildlife values on these properties. The WC needs to advise the Council on the appropriate way to credit these wildlife values.

ITEM 3: Develop an Approach to Work with Resident Fish Committee to Develop Recommendations for Allocating a Portion of the BPA Budget for Resident Fish and Wildlife

The WC members should talk with their respective Resident Fish Committee members to see if they are interested in working together on developing a rationale for dedicating a portion of the BPA budget to resident fish and wildlife projects.

ITEM 4: Review of Pine Creek Ranch Wildlife Mitigation Management Plan

Mark Berry (CTWSRO) will present the Plan and respond to WC questions. The WC must find that the Plan is consistent with the CBFWA O&M Guidelines to allow funding of management plan activities.

ITEM 5: Review Draft Letter to Doug Marker

This letter was reviewed at the June 13 MMG meeting and now needs WC approval before going out for consent mail (see attached).

ITEM 6: Review Three Wildlife Proposals Submitted Under the Northwest Power Planning Council's (NWPPC) Innovative Category

Three wildlife proposals (Proposals 34011, 34015, and 34024) have been submitted for funding consideration through the NWPPC Innovative Project process (proposals available on the CBFWA website at http://www.cbfwa.org/files/province/innovative/projects/id.htm).
