ITEM 1:	Review and Approve Agenda and June WAC Action Notes
Discussion:	Michael Pope added an agenda item to provide an update on meeting with the IEAB.
ACTION:	The agenda was revised and June 19-21, 2007 draft action notes were approved as final.
ITEM 2:	New Item - Update on Meeting with IEAB
Discussion:	Michael Pope gave an update on the IEAB meeting that he, Carl Scheeler, and Ray Entz attended regarding IEAB Task #116 (Wildlife O&M). Michael noted that the IEAB was finding that the wildlife O&M costs for the NPCC program were not out of line with O&M costs associated with other programs. He also noted that they had a good discussion with IEAB and that IEAB appeared have a good understanding of the reasons for cost variability and that they understood our concerns.
	Michael informed the WAC that IEAB had a task to explore alternative strategies for habitat acquisitions including partnering with other programs such as CREP, CRP, Metro, etc. The WAC was not aware of this task and

	will need to be prepared to formally respond to the report. Potential concerns include the surety of these other programs to provide long-term wildlife habitat and the appropriateness of partnering with various programs for wildlife mitigation.
	Patty O'Toole was asked if how the results of IEAB Task#116 will be used to revise the 2008 funding decisions. Patty responded that at this time she did not see any changes to the 2008 budget decisions in the near term.
ITEM 3:	WAC Consensus on Material and Recommendations to Present to MAG for the Program Amendments
Discussion	Brian Lipscomb began the discussion by reminding the WAC that the MAG needs to understand the issues, what in the program needs to be fixed and why. The WAC may need to explore further how to establish biological objectives in terms of the Act.
	The draft program amendment PowerPoint presentation was reviewed for consensus on the issues the WAC proposes to pursue through the amendment process and editing the presentation for the MAG. There appears to be consensus at this time on the general wildlife issues for program amendments.
Recommended Action:	The WAC presentation for the 7/24/07 MAG Meeting was finalized.
