Provincial level by hydro facility

- Habitat units lost
- Acres lost
- Habitat units protected
- Net habitat units gained through enhancement (display with an \* if estimated, show with no \* if net gain is based on a follow-up (HEP)
- Include any crediting concerns/issues

### Subbasin level

- Location of projects
- Dollars spent for acquisition and enhancement
- Leave in pictures of focal species
- List major limiting factors; In many cases, limiting factors are likely the same across subbasins, fragmentation, invasive species, and hydrology.
- RecommendedFinalize a recommended format to be presented to the MembersAction:Advisory Group.
