- Note that F&W program project costs were consistent with costs of other wildlife programs
- Task #117 would be briefly addressed focusing on the fact that any wildlife program funding needed to be consistent with the Program to mitigate the States and tribes for wildlife losses due to the hydro system, and provide long term, assured benefits to wildlife. We should also look at the executive summary, first paragraph of IEAB report on Task 104 prepared in 2006. The letter should also express concern that the managers were not consulted in the report preparation.

There was also disappointment expressed by several WAC members that Task #116 noted potential drawbacks of long-term agreements but did not study in depth the current agreements such as Dworshak and Montana to determine the potential benefits.

ACTION: Michael Pope will draft a letter for Ken MacDonald to circulate for review. If possible, we would like the letter to be ready for the December 5, 2007 Members meeting.

ITEM 4: CHAP Letter

- Discussion: The WAC had prepared a letter to the Council expressing support for projects that explored ecologically based assessments for wildlife projects as alternatives to HEP. Scott Soults led a discussion expressing his concern that the letter as written may confuse issues with the Council. If the WAC had concerns that specific projects exploring the use of CHAP such as the Willamette project and Paul Ashley's project then the WAC should draft a letter of support to the BOG specific to those projects. The need for ecologically based assessments should be addressed in the amendment process as planned.
- **ACTION:** The group agreed with Scott's points. Scott will provide Michael Pope with his ideas for a project specific letter.

ITEM 5: Amendment Workshop

- Discussion: The remainder of the day and Tuesday was devoted to drafting wildlife amendment language.
- ACTION: The draft amendment language will be given to Ken MacDonald and Nate Pamplin for editing and to draft the introductory language.
