Discussion:	During the December 2 WAC meeting there was a discussion regarding inclusion of new wildlife habitat acquisition projects in the wildlife project review. It was suggested that new acquisition projects should be included especially if they are foreseeable in the next three years. There was a suggestion that some standard criteria be developed to guide project sponsors when they develop new acquisition proposals.
Recommended Action:	Ken MacDonald was tasked with drafting a potential set of criteria as a starting point for discussion. The draft criteria have been distributed and are posted for the meeting. At the end of the meeting, it is hoped that the WAC will have a consensus list of criteria.
