Reason for change - Subbasin Summary identified a need to evaluate whether the Hanford Reach functioned as a healthy alluvial river. This was consistent with the overall goals of our research in the Hanford Reach and a very important aspect of providing verification of our results. Thus, we added an objective that will address this need. This raised the overall cost. Preliminary review by CBFWA and ISRP as part of the Columbia Plateau Province Rolling Review has concured with this budget.

Project 21004 - Determination of difficult passage areas, migration patterns and energetic use of upriver migrating salmon and steelhead. FY 2001 budget is \$319,542. This is incorrectly listed in your spreadsheet as \$0. However, the spreadsheet does correctly state that FY 2002 budget is \$0.
